Reuben M. Nashali

Reuben M. Nashali is the Executive Director of the Social Planning Council of Ottawa (SPCO), leading its work in shared governance, strategic planning, and community development. Committed to equity and grassroots leadership, he has redefined SPCO's governance model, expanding committees to amplify diverse voices in policy and programs. He has also modernized bylaws to enhance transparency and sustainability. Reuben's vision ensures equity, shared leadership, and community empowerment remain central to SPCO's mission.



Dr. Terri-Lynn Brennan is an inter-cultural planner with a 30-year career spanning anthropology, public policy, and social equity. She is the Executive Director of the Indigenous charitable organization LodgePole Arts Alliance and leads her consultancy, Inclusive Voices Incorporated. Terri holds a national role as a sector trainer for the Cultural Human Resource Council in Maintaining Respectful Workplaces in the Arts, while advising municipalities on cultural planning and Indigenous relationship-building. Proudly Ohnkwehon:we/Kanien'kehá:ka/Skaru:re? (Mohawk/Tuscarora) and British, she traces her roots to Six Nations of the Grand River, Ireland, and England. Terri lives on Wolfe Island, within the Dish with One Spoon Wampum Covenant Treaty, with her partner and their Portuguese water dogs.



Kelly Wilhelm (she/her) is a consultant and strategist with over 25 years of experience in government, the arts, creative industries, and the non-profit sector. She leads the Cultural Policy Hub at OCAD University and is an Adjunct Professor in its School of Graduate Studies. Her consulting practice focuses on strategy, government relations, equity and inclusion, research, and public policy. Previously, she held senior roles at the Canada Media Fund, Canadian Heritage, Canada Council for the Arts, and as Chief of Staff to a federal minister. Kelly holds degrees from Queen's University and the University of Toronto and lives in Ottawa with her partner and two children.

Toby Fyfe:

Toby Fyfe is a senior executive with experience in the public and non-profit sectors. He spent 19 years in the federal government, leading central agencies and departments in governance, program design, and communications. As President and CEO of the Institute on Governance, he rebuilt the team, achieved financial goals, and guided the organization through crises, including the COVID-19 pandemic. As a consultant, he has helped public sector organizations improve performance, including the RCMP. Previously, he was a CBC Radio producer for 17 years. He is a Senior Fellow and Adjunct Professor at Queen's University and Carleton University.
